

## STATEMENT FROM DMA

Democratic Mayors Association Statement on the Supreme Court's Decision to Overturn Roe v. Wade

WASHINGTON, D.C. – The Democratic Mayors Association (DMA) President Mayor Levar M. Stoney issued the following statement in response to the United States Supreme Court's decision to overturn Roe v. Wade:

"Today is a grim chapter in our nation's history, as the United States Supreme Court has wrongly decided to overturn a landmark decision that has preserved millions of Americans' reproductive rights and privacy. This callous decision waks back nearly 50 years of progress and the tireless efforts of advocates who fought to protect a woman's right to choose.

Overturning Roe not only increases health risks for millions but will bring about graver social and economic implications for many Americans. Unfortunately, the brunt of this decision will fall on impoverished communities and people of color, who already lack the resources to access necessary reproductive healthcare. Beyond these implications, this decision now opens the door for other fundamental constitutional rights to be at risk of reversal.

Democratic Mayors firmly believe that women deserve the freedom to make decisions about their bodies and that abortion is still a fundamental healthcare right. As local leaders, we have already initiated efforts to protect our communities and their reproductive liberties in the wake of federal inaction.

Mayors in <u>Austin</u>, <u>Madison</u>, and <u>Tucson</u> have developed resolutions in preparation to protect their residents and ensure they are not criminalized for exercising their reproductive freedoms. In <u>Chicago</u>, the city has set up a fund to support residents and individuals from neighboring states with transportation, lodging, care, and, if necessary, access to safe and legal abortion procedures. Actions I ke these must continue to protect Americans' reproductive liberties and well-being.

This decision is a clear reminder that elections matter and have consequences. Now, more than ever, we must <u>register</u> and turn out to vote for pro-choice candidates who will defend reproductive rights on the ballot this November."

### Joint Statement From DNC, DSCC, DCCC, DGA, DAGA, DLCC, DMA On SCOTUS Overturning Roe v. Wade

In response to the United States Supreme Court today overturning Roe v. Wade, DNC Chair Jaime Harrison, DSCC Chair Gary Peters, DCCC Chair Sean Patrick Maloney, DGA Chair Roy Cooper, DAGA Co-Chairs Aaron Ford and Kathy Jennings, DLCC Chair Andrea Stewart-Cousins, and Democratic Mayors Association President Levar M. Stoney issued the following joint statement:

"Democrats believe women in America have the right to make their own health care decisions, and that politicians should never get in the way of these private decisions. Today's Supreme Court ruling is the culmination of a coordinated Republican effort to attack this fundamental freedom – but Democrats will fight back with every tool we can, and voters of every political persuasion will hold the GOP accountable in 2022.

"Make no mistake: The Republican Party will not stop at overturning Roe. The 2022 election will now determine whether new, cruel, and punishing restrictions will be put in place on women and families. With Republicans in power, states could make abortion illegal without exceptions for rape, incest, and the life of the mother, and women and doctors could be charged with a crime if they have or perform an abortion.

"The stakes of November's elections could not be higher – and voters will make their voices heard by standing with Democrats up and down the ballot."

## **MAYOR ACTIONS**

#### Austin, TX - Mayor Steve Adler

Mayor Steve Adler and the city council have developed the GRACE (Guarding the Right to Abortion Care for Everyone) Act that would direct Austin police to make criminal enforcement, arrests, and investigations of abortion its lowest priority. The measure would also block the use of city funds and staff from reporting or investigating suspected abortions. The GRACE Act would not be submitted before the full council until the Supreme Court's decision is issued and could come within hours of the ruling.

### Chicago, IL - Mayor Lori Lightfoot

Mayor Lori Lightfoot is pledging \$500,000 through the Justice for All Pledge to support reproductive healthcare for Chicago residents and individuals from neighboring states. The fund will support transportation, lodging, care, and, if

### necessary, access to safe and legal abortion procedures.

#### Tucson, AZ - Mayor Regina Romero

Mayor Regina Romero and the city council passed a resolution that addresses SB1164, which would criminalize people who help with abortion services when Roe v. Wade is overturned. The resolution supports the rights of pregnant individuals, including with abortion, and orders the police department to make no arrests under the abortion ban. This also includes protections under Arizona's 1901 law that bans all abortions. The resolution was developed in collaboration with Tucson Police Chief Chad Kasmar, Pima County Attorney Laura Conover, and City Attorney M ke Rankin and went into effect immediately.

### Madison, WI - Mayor Satya Rhodes-Conway

Mayor Satya Rhodes-Conway and the Common Council have passed a resolution that supports the Madison Police Department in refusing to arrest people, including abortion providers, for any violation of the 1849 statute on abortion in Wisconsin. The resolution also directs law enforcement in the event of receiving a complaint relating to the Wisconsin statute to direct investigations to the Wisconsin Department of Health Services.
